





FY21 – Sewer Rates


Proposed Adjustment (FY21 vs. FY20)

- Residential Rate - \$0.1188/cubic foot - 2% increase
- Commercial Rate - \$0.1188/cubic foot - 2% increase
- Sewer Improvement Fee - \$40.07 per gallon - no change

Impact on Avg. Residential Customer
\$13.97/year
