## Air Purifier Rebate Application

### REBATE INFORMATION

CMLP will provide a rebate to its commercial customers of 50% of the cost of purchasing one or more air purifiers, capped at \$500 per commercial customer per 12-month period. CMLP will also provide a rebate to commercial landlords of 50% of the cost of purchasing one or more air purifiers for tenant spaces, capped at \$2,000 per 12-month period. Commercial landlords must be CMLP customers to receive a rebate.

The following are NOT eligible for this rebate:

- Air purifiers purchased by residential customers
- Dual function air purifiers/heaters
- Labor or equipment for installing air purifiers

This rebate is available for air purifiers purchased on or after July 1, 2020, as shown by date on receipt or invoice. All rebates under \$600 are issued as a credit on your electric bill. Customers may choose to receive rebates of \$600 or more as either a bill credit or a check from the Town. Customers receiving checks of \$600 or more will get a 1099 from Town for the relevant tax year if required by tax code.

Submit the following documents with your rebate application:

**Commercial Customers:**

- Receipts or invoices for air purifier(s), showing equipment make and model, date and CMLP customer name or DBA.

**Commercial landlords:**

- Receipts or invoices for air purifier(s), showing equipment make and model, date, your customer name or DBA and tenant space as delivery destination or intended user.
- If requesting a rebate of \$600 or more *in the form of a check*, submit your W-9 on IRS's Nov. 2017 or Oct 2018 Revised Form.
