Concord's 2024 Annual Town Meeting was held at the Concord Carlisle High School (CCHS) on Monday, April 29, 2024 with 1,131 voters in attendance. The second session took place on Tuesday, April 30, 2024 with 977 voters in attendance. The third session will commence on May 1, 2024 at 7:00pm with the Special Town Meeting as the first order of business. Article 27 will be taken up following the conclusion of the Special Town Meeting.
